Administering an oath or receiving a declaration or affirmation	\$88.00
Effecting, or attempting to effect, service of a document and issuing a certificate or affidavit of service or attempted service of a document	\$88.00
Witnessing a signature or seal on a form or declaration	\$88.00
Preparing a declaration or other document	\$88.00
Verifying and certifying a copy of a document or part of a document	\$88.00
Witnessing the execution of a will	\$88.00

Please be aware the above fees may vary depending on the type of service requested:

- witnessing a client's signature (once or multiple times) throughout a **single** document = one fee of AUD88
- witnessing a client's signature on **multiple** documents = multiple fees of AUD88
- witnessing the signatures of **two** separate clients on a **single** document = two fees of AUD88
- witnessing a client's signature by **two** witness' officers = two fees of AUD88
